

Motion to accept minutes of 06/07/2018 was made by JW Campbell and 2nd by Chuck Mahoney, all in favor.

New Membership: Dailynn Bockhahn (single) and Laurie Pester (family). Motion to accept was made by JW Campbell and 2nd by John Dill. A motion was made for all new members to come to a board meeting or talk with a board member by phone and speak to what they are looking for in the club and also to be sponsored by a member. Motion was made by JW Campbell and 2nd by John Dill. The vote was 6-yes and 2-no.

Treasurer Report: Deb Reuter gave a report of monthly bills due and she also stated that when she paid the insurance with her own credit card, the club had paid her back. Then she found out later a refund was sent back and put on her card in the amount of \$692.00. She then refunded the money back to the club.
